MEMBERSHIP INFORMATION INCLUDING CLUB RULES (*)

Membership

- Under the club's Constitution, all applications for membership are decided by the Committee. Upon approval of an application, an applicant shall become a member of the club and be bound by its Constitution and Rules. Upon rejection of an application, the Committee will, as soon as practicable, notify the applicant and refund any funds paid as part of the application process.
- Club membership is inclusive of all family members over 11 years of age residing in the same house and listed on the application form.* The principal member must be at least 16 years old. Only members aged 16 years and over have voting rights under the club's Constitution.
- Children must be at least 11 years old to handle a dog in class. Club members are responsible for the behaviour of their children at all times while on the club grounds.*
- Only financial members may bring their dogs on to the grounds and must abide by the *Using the Club Grounds* protocols.
- The club does NOT offer grounds use only membership.*
- Prospective members must nominate the training activity/s that they intend to participate in when applying to join the Club. In order to renew and retain access to the club's facilities, members are expected to regularly participate in the club's training activities and must nominate the activity/s that they intend to participate in.*
- Access to the club's car park is restricted to club officials and holders of disabled parking permits (except during trials).*
- Smoking is not permitted in classes, in the clubhouse or in the vicinity of any buildings or pathways.*

Fees

- Joining, membership and activity fees only cover family members and dogs specified on the membership form.
- Fees provide membership for 12 months from the start of the term that enrolment takes effect (ie February through to February, April through to April etc).
- Activity fees are payable per dog enrolled in each activity.
- Activity fees entitle handlers to attend only one training session per week per activity.*

Submission of form and payment methods

- Email, post or deliver your completed form and a copy of your dog(s) current vaccination certificate(s) to the club.

 - Please do not send cash in the post.

Club officials

- Club officials include committee and sub-committee members, instructors, life members and the office manager.

Dogs

- All dogs listed on the membership form must be fully vaccinated against distemper, canine hepatitis and parvovirus in order to use the club grounds. Current Australian Veterinary Association protocols of triennial vaccinations and an annual booster for canine cough are accepted. Proof of immunity must be provided on request. Homeopathic alternatives are not accepted.*
- Bitches in season must not be brought on to the club grounds.*
- All dogs must be kept on lead at all times on the club grounds (including the car park), except in designated off-lead areas and during training sessions (when given permission by the class instructor to work off-lead).*
- Handlers must supervise their dogs at all times in the designated off-lead areas and ensure that their dogs do not interfere with other dogs or club members.*
- Handlers must consider the welfare of their own dog and the safety of other club users when tethering their dog on the club grounds.
- Handlers must clean up after their dogs and use the bins provided at all times.*
- Handlers must not bring a dog suffering from any illness or skin problem on to the club grounds until a vet has pronounced the condition non-contagious.*

Classes

- The club offers four Behaviour Training terms annually, aligned with the ACT Government's school terms. At the end of each term, if ready, dogs may progress to the next training level.
- Behaviour Training terms start in February, April, July and October.
- Behaviour Training classes are held on:
 - Wednesday mornings from 10.00am – 12.30pm
 - Thursday evenings from 6.30pm – 9.00pm
 - Sunday mornings from 9.30am – 12 noon
- Information about Agility, Flyball, Dances with Dogs, Tricks, Rally, Obedience Trialling and Tracking training times can be found on the club's website, in the club's quarterly magazine or by contacting the Office.
- The club uses rewards-based force-free training methods and equipment. This includes the use of flat collars and front-connecting harnesses as well as food and toys.
- Handlers must use approved training methods and equipment at all times on the club grounds and during class activities. Mistreatment of dogs is not tolerated and may result in removal from classes and other sanctions.*
- For the safety of all club members, handlers must follow directions given by club officials (including class instructors) when on the club grounds.

Club shop

- The club shop offers a great range of training equipment including collars, leads, harnesses, treat pouches, toys and food rewards for purchase. All equipment can be custom-fitted for your dog.
- The shop is open during training terms on:
 - Wednesdays from 9.45am – 12.45pm
 - Thursdays from 6.15pm – 9.15pm
 - Sundays from 9.15am – 12.15pm
